Your regular giving will provide emergency food and support local people in crisis.

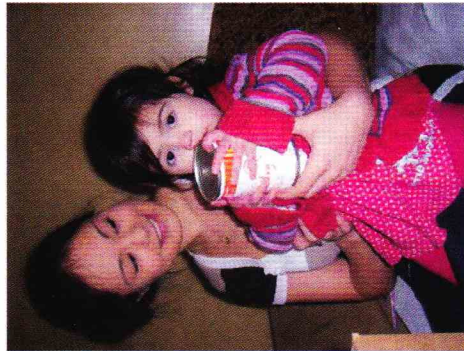
It will also help us to budget effectively and demonstrate to other potential funders that our foodbank is sustainable.
